Aims

The main aim of the conference is to update the status of the threatened Saker Falcon populations, therefore the organizers invite presenters to summarize the status of national or regional populations between 2019 and 2023.

The focus of the workshop will be on the Asian and East-European breeding populations of the species, but presentations from Central and South Europe are also welcomed.

A similar event will be organized in October 2023 in Bulgaria, which will focus on the European populations.

The results of the two complementary workshops can help researchers to update the status and conservation strategies of the Saker Falcon worldwide.

Resolutions

- 1. Updating the global status?
- Recognition of the SakerGAP as the international document that guides international conservation plans
- 3. Acknowledgement of the STF as the International CMS forum where science provides guidance to innovative conservation practices for the implementation of the SakerGAP
- 4. Welcome the Mongolia (and China) efforts to conserve the species by retrofitting powerlines and providing artificial nests
- 5. The resolution should include calls for Participations of scientists to the SFT
- 6. Updating the Saker GAP (which, as we know needs to be done in 2024 and a mention to it is in the proposed amendments to CMS Resolution)

Resolutions

- 1. Updating the Saker GAP (which, as we know needs to be done in 2024 and a mention to it is in the proposed amendments to CMS Resolution)
- Establishing monitoring schemes for the species in all range states
- 3. Further research on the migration pathways of the species in CA (by means of e.g. tagging and genetic research)
- 4. Identification of electrocution hotspots
- 5. Improve law enforcement to control illegal taking and trade
- 6. Call for CMS Parties to continue supporting the work of the STF and its work on AMF and Electrocution."
- 7. in research special attention should be given to the impact of climate change (pro and contra) and disappearing food base that together may fundamentally change the distribution range of sakers.
